French Swindle Being Uncovered

PARIS, Dec. 4.-(AP)-A gigantic swindle, resulting in losses to "investors" of perhaps \$20,000,-000 echoed in the chambers of deputies today and reached the cabinet. Two arrests have been made and authorities declare that the case may equal the operations of Ponzi in the United States and cause as much sensation here as the Panama Canal scandals.

The affair got into the chamber of deputies when M. Chastenet, socialist member from Isere, interpolated Premier Poincare as to "what measure he intended to take to prevent similar occurences in the future," the member adding that he stood ready to name two cabinet ministers who were closely interested in financial companies of a character "not unlike that which has just collapsed."

M. Poincare refused to discuss the satus of his involved ministers. he did, however, say that sterner supervision was being created for control of such projects.

REAL ESTATE MEN SENTENCED

"Okeechobee Shores" ficials Face Fines or **Imprisonment**

MIAMI, Dec. 4.—(AP)—Harold B. Long, who was president, and Frank L. Finch, who was secretary of the Manchester Realty Corporation, "owners and developers of 'Okeechobee Shores'," subdivision during the 1925 real estate boom, pleaded guilty before Judge William I. Grubb in U. S. District Court today to indictments charging use of the United States mails in the fraudulent promotion of real estate sales.

Long was sentenced to 15 months in the Atlanta, Ga., penitentiary, suspended upon good behaviour during the next five years and fined \$2,500. Finch was fined \$1,500. Both were allowed six months time to pay the fines.

Fraudulent Claims.

They made fraudulent representations concerning the ownership and financial backing and the proposed development of 1.143 acres of land on the east side of Lake Okeechobee in Martin county. Their literature described "Okeechobee Shores" as "A city of unwavering opportunity."

There are fifteen other mail fraud cases in connection with real estate sales on the docket, one involving Fulford-by-the-Sea, which is scheduled to come up for trial at the spring term of court.
